competition. With knowledge of these risks, I consent to the minor's participation. This declaration does not
exclude or limit the Organizer's liability in situations where such liability cannot be excluded or limited under
applicable law.

I understand that participation in a competition of this level requires appropriate technical bicycle-handling
skills. I undertake to provide the minor I represent with the protective equipment required for such an event,
including a helmet, appropriate protective gear, and a bicycle in good working condition, and I confirm that this
equipment will be used throughout the race route and during any training sessions, if applicable.

I confirm that the minor I represent will follow the organizers' instructions throughout the event and comply
with their decisions whenever such decisions are made in the general interest and for the proper conduct of the
event.

I understand that I will not hold the race organizers responsible if the minor I represent is disqualified from the
competition for failing to comply with the race regulations.

I further declare, on my own responsibility, that:

- The information provided above is accurate;
- I have read the Participation Regulations published at <https://tbtrace.ro/regulament>, I agree to them, and both I
and the minor I represent will comply with them in full;
- Based on the information I have regarding the minor's health, I consider the minor fit to participate in this event
and I take responsibility for seeking medical advice in advance whenever the minor's health condition requires it;
- The minor I represent has the psychological and technical preparation appropriate for participation in this
competition;
- I understand the implications of participation and accept the responsibilities that apply to me under the law as
the minor's parent / legal guardian / legally authorized representative;
- The minor I represent has a bicycle in good working condition and the protective equipment required for this type
of competition, including a helmet and other appropriate protective gear;
- I understand that my personal data and the minor's personal data are processed by the Organizer for purposes
necessary to organize and conduct the event, in accordance with the data protection information available on the
TBT Race website;
- I understand that the minor's name, age, and sex may appear on public participant lists and results;
- I agree that both the minor I represent and I may be photographed and filmed during the event, and that the
organizers may use the images, recordings, and associated rights arising from materials produced during the
event.
